If you have an interest in serving on the Board, please call Past President Anne Shutter at 717-273-4346 before the March meeting. Anne will be able to review the duties of each position.

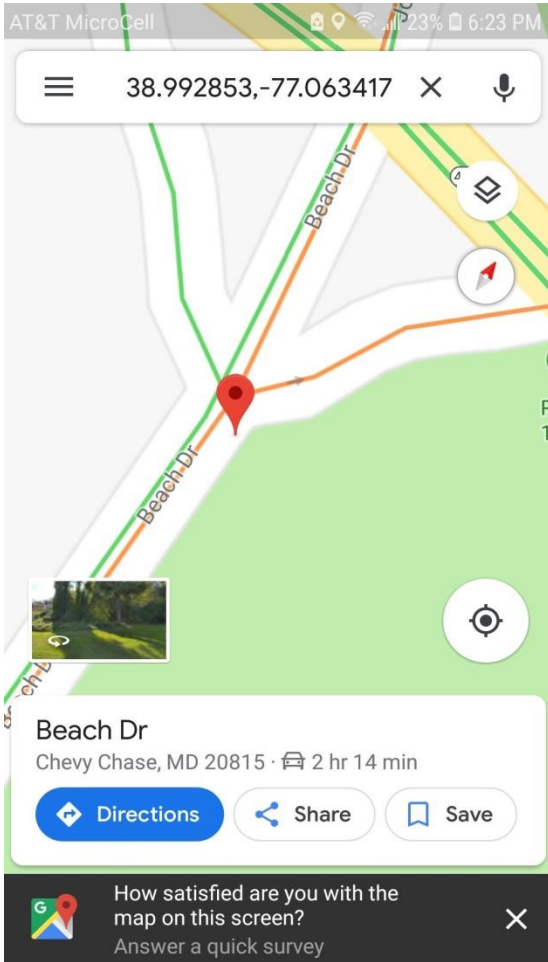

SWATARA STATE PARK BIKE RIDE SUNDAY, JUNE 23rd

Make ready your bikes, we're going to ride!

We will meet at the Lickdale Campground at 1:00 p.m. on SUNDAY, JUNE 23 and proceed to a nice parking lot in Swatara State Park for the group to start their ride. The ride will be rail-trail and mountain biking so a road bike is not recommended. The rail-trail is flat and will cover approximately 20 miles from Lickdale to Pine Grove and back. We will be riding on both sides of the Swatara Creek completing a loop with a riding only bridge at the half-way point in the event anyone only wants to ride half of that distance. On the return we will make a brief stop at the historic Bordner Cabin. The cabin was built by in 1939 by local high school teacher, Armar Bordner, and some of his students. By chance Terry's Dad was one of those students. The rustic cabin was his home until the state tried to seize under eminent domain. Bordner resisted and eventually was allowed to return and stay in his home until his death. Directly outside the cabin's giant picture window, Aycrigg's Falls comes down the hill in a series of 4-5 drops with the top now being a draining pipe directly under Interstate 81. A great place to take a break, enjoy the beauty and cool down along the falls.

When beginning the ride, will enter the mountain bike loops for a taste of mountain biking, if the group chooses. The mountain bikes trails are approximately 10 miles consisting of 6 loops. The plan will be to enter the mountain bike trails and ride one loop, the newest and easiest loop. If you have no interest in riding that loop, Ron Birch will be happy to take a group on a rail-trail only adventure. If you choose the mountain bike loops, Terry and Nick Resanovich will guide you through with one of them sweeping and riding at the back of the group while the other leads. No rider is ever left behind and if that group only wants to ride a loop or two we will cut it short and continue to rail-trail meeting back up with Ron and his group. Plans for post-ride to follow.....

MT. WASHINGTON, NEW HAMPSHIRE HIKING TRIP

**CALLING ALL HIKERS (AND GOLFERS AND SHOPPERS TOO !!)
September 8 – 12, 2019**

As of this newsletter, I have 13 Members who have interest. Members can come for all five days, or can stay for fewer days.

SUGGESTED ITINERARY:

- September 8th - Drive in a carpool - 9 hours, 525 miles.
- September 9th – 11th – Three hikes – See Info Below
- September 12th – Return home

LODGING: Lodging will be either at a motel/hotel, camping or RV. We will not try to rent a house. Four of us so far will be staying at a hotel north of Mt. Washington called the Glen House at <https://theglenhouse.com>. If you would like to join us, you will need to make your own reservations. There are also other motels/hotels and cabins in the area in addition to campgrounds.

HIKING:

- 1st day: hike Tuckerman Ravine Trail, the famous trail to summit, 5.8 miles roundtrip, all day hike.
- 2nd day: hike Franconia Ridge/Falling Waters/Bridle Path trails, great hike, 9.0 miles roundtrip, all day hike.
- 3rd day: hike Jewell Trail, return on Cog Railroad. Easiest hike and it's only one way. [All hikes are alpine starts with the exception of the Jewell Trail, so we don't have to rush and get out by dark] All are hiking only, no climbing.

OTHER ACTIVITIES:

The White Mountains are the hiking capital of the east. This trip is all about hiking and that will be our objective. BUT, we could ride the Cog Railroad up and back from summit, or we could drive to the summit. Train ride from North Conway through the mountains- approximately a 4 hour trip.

Golf at Sunday River (yes, one of our favor skiing resorts), a 35 minute drive.

Shopping in the very small towns. Grocery shopping in Maine for lobster for everyone!!!

Highest summit wind speed in the world other than tornados/cyclones, 231 mph.
41 degrees average summit temperature in September.

1. TRIP/EVENT SIGN-UP AND PAYMENT

- A. Everyone participating in Club trips must be a current member of the LSSCI INITIAL _____
- B. Everyone participating in Club trips must be at least 18 years of age, unless accompanied by a Parent/Legal Guardian.
- C. Registration for all Club trips involving overnight stays, payment, or common transportation, must include this registration form and the initial deposit. Deposits shall be made by check made payable to the **Lebanon Ski and Sport Club, Inc.**
- D. Everyone under 21 years of age must abide by all state laws governing alcoholic beverage consumption. Any individual under 21 years of age who consumes alcoholic beverages or any Club member, who furnishes any individual under the age of 21 with alcoholic beverages, shall be prohibited from participating in any additional Club trips. In addition, the Board may expel said individual(s) for violations of this policy.
- E. Trips will be filled as follows:
 - 1. Registrations will be accepted in the order they are received. Deposits and registration forms are to be given to the trip leader assigned to that trip. Trip Leader addresses will be listed in the monthly newsletter.
 - 2. The initial deposit amount and the schedule for the remaining payments will be stated in the official trip announcement. Payment schedules will also be listed in the monthly newsletter.
 - 3. The Club makes reasonable efforts to pair members to fill rooms to meet the occupancy rate. However, due to the variety of room configurations, parties signing up for trips with less than required occupancy may incur additional charges to cover room costs not otherwise covered. INITIAL _____
