September Club Meeting

The club meeting will be held on Tuesday, September 1 at 6:00 p.m. in Heidi and Trevor's backyard at 16 Killinger Road, Annville, PA 17003.

Please bring your own lawn chair, snacks, beverages, and a mask (not required outside but in case you need to use the off the garage restroom). We will socially distance in the backyard for our meeting. In case of rain, we will meet in their garage with the garage doors open and under pop up tents.

When you arrive at their house, you can park in the front yard, driveway, or either side of the house. Please just do not block the farm lane that their driveway is off of. If needed, additional parking is also available next door at 10 Killinger Road (off white brick ranch house next to theirs).

- *Take 422 through Annville.*
- *When you reach the new Annville Rutter's on the left hand side, turn left onto Killinger Road. Follow Killinger Road and you will pass a farm, cross over a bridge, and then their house is the 4th on the left. It is a red brick ranch house with black roof and black shutters. The farm lane is between 3 mailboxes and a telephone pole painted white. You can pull into the front yard directly from the road (just mind a few areas with trees).*

Directions from 422 from Palmyra/Hershey:

- *If you are heading from the Palmyra square head towards Walmart. But right before the Palmyra Bowling Alley/Sinkhole location, turn right onto Plaza Drive (its right after the Northwest Bank sign). Go up the hill on Plaza Drive and then turn left to stay on Plaza Drive. You will pass a farm on your right, the LondonCroft Development on your left, and then once you are up the hill and are driving around a slight bend, you will turn left onto Killinger Road. Their house is the second house on the right hand side. It is a red brick ranch house with black roof and black shutters. The farm lane is between a telephone pole painted white and three mailboxes on the right. You can pull into the front yard directly from the road (just mind a few areas with trees).*

Directions from 322 from Lebanon:

- *Take 322 toward Palmyra. When you get to the intersection of Forge Road (Mt Gretna Brewery/Leed's Corner) turn right. Go through the round-a-bout and then take the next right turn on to Hoffer Road (this also takes you to In the Net). Follow Hoffer Road. You will turn right onto Killinger Road (it is after the left hand entrances to the Old Stone Way development). Their house is the second house on the right hand side. It is a red brick ranch house with black roof and black shutters. The farm lane is between a telephone pole painted white and three mailboxes on the right.
