BIKE RIDE ON THE CUMBERLAND VALLEY RAIL TRAIL

Friday, June 10, 2022

The Cumberland Valley Rail Trail is 13.7 miles through a valley that is hemmed in by the Blue and South Mountains. The path is mostly crushed limestone, though sections in Shippensburg and Newville are asphalt, as are numerous road crossings along the way. The trail traverses wooded areas and farmland between Shippensburg and Newville.

Meet at the parking lot at 9:00 A.M. at the PA Turnpike Lebanon/Lancaster interchange on Route 72 and we will caravan to the Shippensburg Station trail head located at **51 East Fort Street, Shippensburg, PA** (near Shippensburg University). Approximate drive time from Lebanon is 1.5 hours. After riding we will enjoy "burgers and beer" at the Appalachian Brewing Company located near the trail head in Shippensburg.
